Dear Educator,

I'm excited to announce that at both the regional AND state competition levels in Pennsylvania, <u>Poetry Out Loud</u> is now back to 100% in-person! After 3 years of working through a variety of virtual and hybrid contests, being back to all live poetry is great news!

Additional great news is that while not yet confirmed, it looks like the state competition will be held at the renowned *Rock Lititz* in Lititz, PA! If you're not familiar with Rock Lititz, it is an amazing production community on a 108-acre campus that supports live productions of all kinds. Keeping our fingers crossed it will work out!

If you haven't yet participated in Poetry Out Loud, as so many schools and students have over the programs 18-year history, this will be a terrific year to get started and experience the power of spoken words in poetry.

The program uses a pyramid structure that starts in the classroom with students advancing to a school competition to determine a school champion, followed by regional and state competitions, and then a national competition. There are cash prizes at both the state and national levels.

In his *Preface to Lyrical Ballads*, William Wordsworth wrote, "Poetry is the spontaneous overflow of powerful feelings; It takes its origin from emotion recollected in tranquility." That is most certainly still true, which allows <a href="Poetry Out Loud">Poetry Out Loud</a> to not only be a part of students learning, but that emotional release that speaks directly to the many feelings they have experienced over the past 3 years.

On behalf of the Pennsylvania Council on the Arts, the National Endowment for the Arts, and the Poetry Foundation, I invite you and your school's participation in the **Poetry Out Loud** program, taking place again in high schools throughout Pennsylvania this coming school year.

# 2023-2024 PENNSYLVANIA POLICIES & GUIDELINES FOR POETRY OUT LOUD COMPETITION

- 1. Students must not be given any monetary prizes or gift certificates. (This may be revisited if a sponsor is secured who can provide equal prizes for all regional competitions.)
  - One of the PCA's long-standing funding restrictions is: "PCA funds cannot be used to support cash prizes and awards" even if the money comes from a different source....
  - There is not enough money in the budget to support prizes, even if we were permitted to do so.
  - All participants must receive the same access and opportunities across the state
- 2. Each participating school or community group must be given the opportunity for one student to attend the regional competition. No more.
- 3. Poetry Out Loud is designed for high school students, which is typically grades 9th-12th. All 9<sup>th</sup>-12<sup>th</sup> grade students ARE eligible to participate in POL whether they are in a Junior or Senior High School. Eighth graders can be included if they are doing ninth-grade coursework in the classrooms that are conducting the program.
- 4. Community Groups such as scouts, local arts councils, etc. are permitted to conduct their own POL competitions and send their top winner to the regional competition. Students participating in these community events may only be eligible for regional and state contests if their school district is not participating in POL.
- 5. Each school/group champion must be prepared to recite three poems at the regional competition.
- 6. From the NEA: re: poem selection for state and national finals. 1) One of the three poems must be pre-20th century.

  2) One of the poems must be under 25 lines in length. Both requirements are made to encourage students to look more broadly at the poems available, to encourage their choosing classic poems and those that do not inspire a long, dramatic interpretation. "Sort" categories are on the website anthology to help students find poems that meet these criteria. Be sure that students are not choosing a "retired" poem.
- 7. Judging/Scoring
  - Each regional competition should strive to have a minimum of three diverse interpretation judges (gender, ethnicity, geography and expertise; for example: actors/directors, poets/writers, government officials-local/county/state/federal, librarians, media managers/artists, educators.)
    - The ArtsPath virtual panel will consist of 5 interpretation judges.
  - One person should be specifically assigned to be the accuracy judge. *Ideally this should be a person in addition to the three judges mention above.* Judges should NOT be the teachers or coaches of any of the contestants.
    - The ArtsPath virtual panel will consist of 1 accuracy judge.
  - In-person competitions will always have one prompter.
  - Judging is based solely on scores. In case of a tie: the highest "Overall Performance" score should determine the winner. If a tie persists, then the highest accuracy score should determine the winner. This is consistent with the NEA and PCA.
  - Score sheets provided by the NEA/PCA must be used.
  - Judges must not be paid a stipend to judge. If there might be travel, their travel can be reimbursed. This is consistent with the NEA and PCA.
- 8. School Contests should take place in time for the school champions information (poems, bio, photo) to be sent to ArtsPath NLT Wednesday, January 31, 2024.

"Getting out of my comfort zone and trying something that was completely new to me."

"It gave me a greater appreciation of all the different styles of poetry and the many talented artists that wrote them. Whereas before I only saw poetry as a part of my school curriculum in English, now I see it as and art, kind of like acting and theater, it is very versatile and can be molded into what ever you want it to be."

"By memorizing and reciting a poem, you make it a part of you, which necessitates gaining some understanding of it. You have to figure out what it means and how you are going to present it to your audience. It also becomes more personal to you and you appreciate something new about it with each recitation."

"Reading words is great, but they are also meant to be spoken. The way that you say things is so important, and with poetry, which is meant to convey emotions and tell stories, it's crucial. There are poems I didn't get AT ALL before POL that I now love."

"I entered because I am a competitive speaker. Next year I will enter, because I love poetry."

"It has humbled me in a way to be involved with the poems I read. Instead of worrying if I can understand all the words or if it rhymes, I focus on content with which it describes. Poetry is so wonderful and so mysterious that I wish more people would appreciate it."
