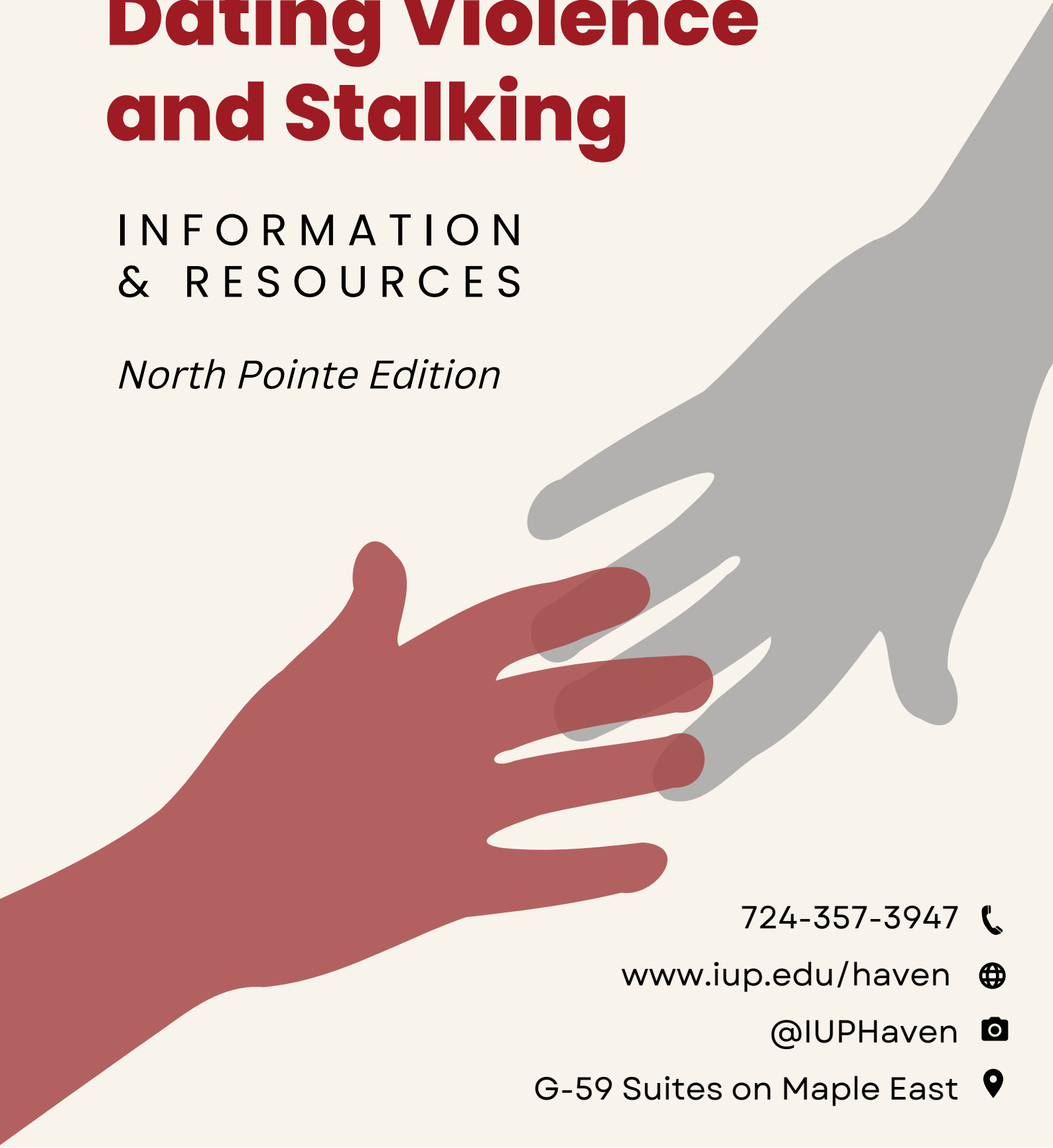

What if I am afraid to report?

A witness to or individual who experiences sexual misconduct, acting in good faith, who discloses any incident of sexual misconduct to University Officials or law enforcement may not be sanctioned under the IUP Community Standards Policy for violations of alcohol consumption and/or illegal drug use policies occurring at or near the time of the incident(s) of alleged sexual misconduct.

SOCIAL EQUITY & TITLE IX OFFICE

Title IX Coordinator and Title IX Deputy Coordinators connect students with support resources and provide information about disciplinary and legal processes.

The Title IX team addresses sexual assault, dating or domestic violence, sexual exploitation, stalking, and other issues including gender-based discrimination and sexual harassment.

The Title IX Coordinator is a resource to provide support. Meeting with someone from the Title IX team does not obligate a student to take additional action. We are here to help.

24 HOURS HOTLINE

HAVIN hotline is staffed 24 hours a day, 7 days a week for crisis counseling and information and referral. Hotline is available to anyone who needs help in Domestic Violence, Sexual Assault & Stalking situations.

EMERGENCY SHELTER

A secure, confidential shelter is available for individuals who are unsafe in their homes due to Domestic Violence and/or Sexual Assault. Shelter approval is dependent upon availability. Advocates are available 24/7 to assist guests in support, education, options & information and referral to community resources.

MEDICAL SERVICES

If you have been abused or assaulted, you may need medical care. To get medical help, immediately go to the nearest emergency department.

If you were sexually assaulted, you should receive information about pregnancy and/or disease prevention. You can also have evidence collected at an emergency department. Evidence collection should occur as soon as possible.

TO PRESERVE EVIDENCE:

- **DO NOT** shower, bathe, wash any part of your body.
- **DO NOT** use the bathroom.
- **DO NOT** change your clothes.
- **DO NOT** brush your teeth or gargle.
- **DO NOT** comb your hair.

PENNSYLVANIA STATEWIDE AUTOMATED VICTIM INFORMATION AND NOTIFICATION (PA SAVIN)

The Pennsylvania SAVIN system is a service through which victims of a crime can use the phone or Internet to search for information regarding the custody status of their offender and to register to receive phone and/or email notification when the offender's custody status changes.

The VINE toll-free number for the PA SAVIN system is **(866) 972-7284**.

This service is provided to assist Victims of Crime who have a right to know about their offender's custody status.

The Campus Sexual Assault Victim's Bill of Rights requires all colleges and universities participating in federal student aid programs afford sexual assault victims certain basic rights.

- ✔ Survivors shall be notified of counseling services.
- ✔ Survivors shall be notified of options for changing academic and living situations.
- ✔ Survivors shall be notified of their option to notify law enforcement.
- ✔ Survivors shall be informed of the outcome of any disciplinary proceeding.
- ✔ Accuser and accused must have the same opportunity to have others present.
