Delete "The course" wherever it is in the course description. Replace "3sh" with "3cr." Percentages on exams don't add up to $45 \%$. Provisionally approved on a Craig/Lewis motion.
E. 09-10b COSC 356 Network Security, course revision, catalog description change Delete "the course" in the course description. Change " 3 sh" to " 3 cr." Approved on a McCombie/Lewis motion.
F. 09-24i MATH 413 Methods of Teaching Mathematics at the Middle Level, new course

Provisionally approved on a Hyde/Migyanko motion. Metz abstained. Change "sh" to "cr," correct pre-requisite number for " 310 " (it's no longer MIDL 112). Delete paragraph at "framework" preceding outcomes. Reword catalog description.
G. 09-24j MATH 153 Elements of Algebra, new course

Provisionally approved on a McCombie/Lewis motion. Add "computer technology" to Outcome 8. Prep and teaching are all in the 3 hrs designated for field work.
