V. Items for Review/Possible Action:

- a. 12-95b ANTH 211 Cultural Anthropology, course revision
 - Catalog description should be with "Introduces..."
 - Remove page 1 from the proposal—it appears to be an earlier version
 - Check catalog description change on cover sheet
 - On a Greenawalt/Fair motion the course was provisionally approved.
- b. 12-132b FDED 440 Orientation to Teaching in Urban Centers, course revision
 - 100 points for participation – expand on how this will be evaluated
 - How is the content changing to reflect the change in credits? Only 2 assignments have been eliminated, including the research component.
 - Shouldn't the proportion of the grades change as well?
 - General concern was raised about the removal of the qualitative research component for a 400 level class
 - On a Lewis/Deckert motion the proposal was returned. Migyanka abstained.
- c. 12-132a Urban Track within the Early Childhood, Special Education Major, program revision
 - Has not yet been approved by Liberal Studies.
 - On a Lewis/Greenawalt motion the revision was provisionally approved pending LS approval and approval of FDED 440.
- d. 12-22 INDS 405 Interior Design Professional Practice, Writing Intensive Type 2 approval
 - Eliminate Catalog Description Change from cover sheet because writing intensive status is not part of the catalog description.
 - Under Writing Assignments, should item 1 should have 'yes' for graded.
 - On a Lewis/Greenawalt motion the changes were approved.

- e. 12-102 HIST 385 People in Nature: An Introduction to Environmental History, new course
 - Catalog description should begin “Examines the ways...” Also, “examines the following comprehensive...”
 - On a Deckert/Lewis motion the course was approved.
- f. 12-103 ENGL 122 Introduction to English Studies, course revision
 - On a Metz/Knight motion the revision was approved. Deckert abstained.
- g. 12-120 COMM 101 Communications Media in American Society, course revision
 - Exam 3 is missing from the outline. Or change evaluation methods to 3 exams, 20% each
 - Do they want the statement “Required for Majors” included as it is in the current catalog description?
 - On a Migyanka/Fair motion the revision was provisionally approved.
- h. 12-121d ECON 239 Economics of Sports, course revision
 - Page 2, should be 3c-0l-3cr
 - On a Knight/Killam motion the revision was approved.
- i. 12-126 MATH 123 & 124 Calculus I & II for Physics, Chemistry & Mathematics, remove from Liberal Studies Elective Category
 - On a Fair/Killam motion the proposal was approved. Metz abstained.
- j. 12-131 Early Childhood PreK-4th Grade with Special Education Pre-K-8th Grade, program revision
 - Liberal Studies has not yet approved this.
 - On a McDevitt/Greenawalt motion the revision was provisionally approved. Migyanka abstained.
- k. 12-133 EDEX 415 Preschool Education for Children with Disabilities, catalog description change
 - On a Van Dyke/Metz motion the description was approved. Migyanka abstained.
