I guess it looks "OK". Page 6, in the parenthesis, it should be "both". If I'm reading everything correctly, on-line students submit an individual presentation, and the in-class students do a group presentation? Or am I missing something? I would agree to accept it.

Comment 2:

To add to what was already said, also on page 6, in the second paragraph under "Online Discussions:", it states, "After studying these sources, you will have until Wednesday evening to post a thoughtful, well-articulated response to the posted." Should 'to the posted.' say something like 'to the original question.'

More importantly, there are SEVEN objectives listed under the Course Outcomes for the original syllabus. The question regarding how the course objectives will be met via distance education is also answered, BUT the online syllabus only has THREE objectives for the Course Outcomes???

Comment 3:

I concur with what was previously indicated. The online syllabus does not speak to the Course objectives but course outcomes. That is where I think the disconnect is. A simple fix is to add the Objectives above the Outcomes. One question I have is she indicates that the course content is predominantly done via lecture, but no indication of how lectures will be done online.

Comment 4:

She did state that there will be PowerPoints and voice recordings to present the information. It looks like a provisional approval is in the works so far. Let me know how you vote for a provisional approval.
