  - iii. Controlled electives: Numbers are wrong; other requirement needs credits.
  - iv. Doesn't have total number of credits.
  - v. CHES? Certified health education specialist—write out?
  - vi. Highlight changes/strike outs in red
  - vii. BIOL 113 not offered anymore so may want to remove.
  - viii. Nothing in rationale saying why BIOL is now being offered.
  - ix. Social science list left off right side is that intentional?

  - ii. Needs better verbs in SLOs for outcomes; higher level verbs
