#### I. Call to Order

### III. Co-Chair's Report

- -- Policy statement on overlap between major and minor courses. System says there should not be an overlap. Provost agreed there could be a two-course overlap. The Registrar's office has been using this policy.
- -- The committee agreed to the following rewording:

"Students may not apply more than two of their major courses toward fulfillment of minor requirements. Prerequisites, Liberal Studies courses, college core classes, and cognate classes in other departments do not count toward this total."

- a. 19-31 ARED 323 Community and Museum Art Education, distance education On Killam/Irani motion to approve
- b. 19-1 Change of Liberal Studies Requirement for tracks in Management Department, program revisions
  - i. Under Section A Why is the course being revised/deleted?

Liberal Studies recommended to change the wording from "We want to limit the third social science..." to language that takes out the word "limit" and instead include language that states they want to encourage students to consider taking courses that meet the GMA requirement while fulfilling their social science requirements.

ii. Under Section B University Senate Summary of Rationale

Include an additional sentence that states this addition is to provide assistance to advisors when recommending Social Science courses to students.

### iii. Under Proposed Catalog Description

The Liberal Studies Committee recommended to include the word **recommend** and the word **and Social Sciences:** ECON 121, PSYC 101, and a Global **and** Multicultural Awareness course (**recommend**).

#### c. 19-24 RLST 120 Comparative Religious Ethics, new course

- LSC says: Remove from the Liberal Studies Elective-Global Citizenship category. We typically allow courses to only fulfill one category: Knowledge Area or Liberal Studies Electives. Fixed in the meeting.

   Include a line that explains why this course fulfills Global and Multicultural Aware

Include a line that explains why this course fulfills Global and Multicultural Awareness. (The LSC agrees that the committee fulfills the requirement, we just need it to be written out in the rationale.)

- Correct typo in **Section P Brief Course Outline** Roman Numeral III fix spelling of Gandhi.
- Take out future tense in course catalog, corrected in meeting.
