#### **BTED 101 Computer Literacy**

3c-0l-3cr

An introductory course providing a fundamental understanding of computers. Familiarizes students with the interaction of computer hardware and software. Emphasizes the application of microcomputers, the use of productivity software (word processing, spreadsheet management, file and database management, presentation graphics, web browsers, search strategies, and e-mail), and the social and ethical aspects of the impact of computers on society. Note: cross-listed as COSC/IFMG 101. Any of these courses may be substituted for each other and may be used interchangeably for D/F repeats but may not be counted for duplicate credit.

#### 2. Proposed Change

The change proposed is the transfer of the course from the Department of Technology Support and Training, Eberly College of Business to the Department of Adult and Community Education, College of Education and Educational Technology. There are no proposed changes to the course title, prefix, credit hours, content, or syllabus of record.

#### BTED 101 Computer Literacy

3c-01-3cr

An introductory course providing a fundamental understanding of computers. Familiarizes students with the interaction of computer hardware

and software. Emphasizes the application of microcomputers, the use of productivity software (word processing, spreadsheet management, file and database management, presentation graphics, web browsers, search strategies, and e-mail), and the social and ethical aspects of the impact of computers on society. Note: cross-listed as COSC/IFMG 101. Any of these courses may be substituted for each other and may be used interchangeably for D/F repeats but may not be counted for duplicate credit.

## 3. Rationale for Change

The rationale for transferring the course to the College of Education and Educational Technology is that it is integral to the undergraduate Business Education degree. While not a required course for the major, it is an important course that is routinely recommended to students in the program because it fulfills a liberal studies requirement and provides a solid foundation for their preparation as business education teachers.

It is important to have sections of BTED 101 taught by faculty in Adult and Community Education during the academic year 2014-2015. This will enable the course to be focused on computer literacy issues related to K-12 education while still meeting the objectives in the syllabus of record. Faculty will be able to contextualize the liberal studies learning objectives in an educational context, thereby addressing state and national technology standards for teachers. The Information Management and Computer Science sections are not contextualized in education and therefore do not address the state and national standards. Ultimately, sections of BTED 101 taught by Adult and Community Education faculty will provide undergraduate Business Education students not only with a solid foundation in computer literacy, but, also with an educational experience that is more relevant to their career goals.

In addition, teaching the course during the academic year 2014-2015 will help Department of Adult and Community Education faculty to prepare a curriculum proposal to develop a liberal studies course to replace BTED 101 for subsequent years (see item #4 in the memo below, under the Part III. Letter of Support).

The following was agreed to among Provost Moerland, Dean Lara Luetkehans, and Dean Bob Camp regarding the offering of BTED 101 in the during the 2014-2015 academic year (fall and spring semesters only).

- 1. Beginning in fall semester 2014, the College of Education and Educational Technology )will take over the course BTED 101, and offer two (2) sections ONLY in the fall semester, 2014, for Education majors. The College of Education and Educational Technology will also be allowed to offer two (2) sections ONLY of BTED 101 in the spring 2015 semester. No sections of BTED 101 will be taught in winter 2014 by either college. Under no circumstances will the College of Education and Educational Technology offer sections of BTED 101 after the spring 2015 semester.
- 2. The Eberly College of Business and Information Technology will cease offering BTED 101 beginning fall semester 2014. Dean Camp will request that the Management Department not pursue its current curricular proposal to eliminate BTED 101 from the curriculum until after the spring 2015 semester.
- 3. The College of Education and Educational Technology will immediately prepare a curriculum proposal requesting the transfer of BTED 101 according to the present agreement and will move this proposal through the appropriate curricular channels as soon as possible.
- 4. During the academic year 2014-2015 the College of Education and Educational Technology will create a new course for Education students that will take the place of BTED 101 in those curricula for which it serves as a liberal studies elective. It is anticipated that this new course will not continue to be cross-listed with COSC and IMFG 101.
