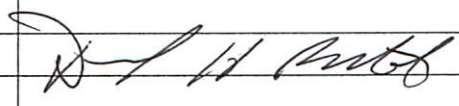
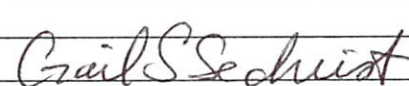

Provost's e-mail:

Dear Colleagues,

As you know, we are in the final year of our implementation of the new Liberal Studies curriculum. The focus this year is on the Writing Across the Curriculum category. The delay in getting the revision information to you is due to my request to the Liberal Studies Committee to create a streamlined process for revisions as part of our efforts to simplify the curricular process. The procedure will follow the usual review process for W approval: Namely, the Liberal Studies Committee, then the UWUCC, and then the Senate.

In an effort to ease the burden on faculty we are asking that **only** those Writing Professors and Courses that were approved before the 2008-2009 academic year be renewed. All writing faculty and courses that were approved after 2008-2009 are considered to be "grandfathered" and will NOT need to be renewed.

If a course or a faculty member does require a renewal, an application will need to be submitted by April 8, 2014 in order to be considered for the last Senate agenda of the academic year. Renewals received after the aforementioned date will be considered when received but will not receive the W designation until the semester after their Senate approval. Our goal is to have 80% of the revisions done by the end of the 2013-2014 academic year.

The three different types of W authorizations are: Type I – Professor Makes a Commitment to Writing; Type II – Department Identifies a Writing-Intensive Course; and Type III – Professor Submits an Individual Course Application.
