 - 1) Catalog description change for availability of a criminology minor.
- 3. Rationale for change. Currently, the criminology program has approximately 931 undergraduate majors and 60 minors. Additionally, the department offers classes to 134 pre-law students from other departments. Of the 931 majors, 328 (35%) are freshmen. Based on current recruiting trends and future staffing projections, it is anticipated that the department will have insufficient allocations (faculty) to continue to provide required classes for criminology majors, criminology minors, and pre-law students. The department's primary obligation is to its undergraduate majors, followed by its obligation to the pre-law program (changes would impact other departments). Restricting the minor will assist the department in fulfilling its obligations to its undergraduate majors and to other departments' pre-law students. Since a criminology minor is mandatory for completion of the Computer Science/Information Assurance Track, this obligation will continue to be honored so as not to impact the students enrolling into that program.

Part III. 1. How will the proposed revisions affect students already in the existing program?

Students in the existing program will be permitted to complete their minor in criminology. Starting Spring 2011 (201050) students will no longer be permitted to select a criminology minor unless they are enrolled in the Computer Science/Information Assurance Track.

Part III. 2. Are faculty resources adequate?

The reduction of criminology minor students releases faculty assets to facilitate required criminology courses.

Part III. 3. Are other resources adequate?

The reduction of criminology minor students reduces the resource requirements for the department.

Part III. 4. Do you expect an increase or decrease in the number of students as a result of these revisions?

The revisions will have no impact on the number of criminology undergraduate students.

Part IV. Periodic Assessment

Part IV. 1. Describe the evaluation plan. Include evaluation criteria. Specify how student input will be incorporated into the evaluation process.

Long-term program assessment is conducted through the five-year review, which incorporates both an outside reviewer and input from current and past students. Annually, informal program assessment is conducted by the department's undergraduate curriculum committee; with input from the Temporary Faculty Screening Committee, the Criminology Teaching Circle members, the Criminology Advising Center, the Department's Executive Committee, and student input solicited or unsolicited by faculty members and the criminology advising center. The multiple source information is distributed/shared through various venues with the faculty members and the department's chair. Any shortcomings are then addressed through policy recommendations to the faculty from the appropriate committee (undergraduate curriculum committee, executive committee, advising center, etc.).

Part IV. 2. Specify the frequency of the evaluations.

Program evaluations are on-going and issues are addressed as identified. A formal program assessment is conducted every five years, but semester and annual program evaluations are conducted by the department's undergraduate curriculum committee at the beginning and end of each semester, focusing on retention, recruitment, student issues and concerns, advising center data, etc.

Part IV. 3. Identify the evaluating entity.

Internal assessments are ongoing, with the primary evaluating entity being the department's undergraduate curriculum committee with input from other internal and external committees, individual faculty members, students, and the advising center. Long-term assessments are a combination of internal and external evaluators.
