Part II. Description of Curriculum Change

1. Catalog Description

Current version:

The program leading to the Bachelor of Arts degree with a major in Music gives the student a general experience in music. The student seeking this degree has the choice of three tracks: Music/General Studies Track, Music History/Literature, or Music Theory/Composition. Students wanting to choose the Theory/Composition Track must audition to enter the Music Department in any other music degree. Entrance to the Theory/Composition Track occurs after completion of Theory I-IV, Theory Skills I-IV, and Composition I, which, for the prospective major, is to be taken concurrently with Theory IV and Theory Skills IV. On completion of these courses with a 3.00 GPA or higher, the Theory Composition Area Coordinator will advise the student into the Bachelor of Arts Music-Theory/ Composition Track. The prospective major must begin study of piano (either Class Piano or Applied Piano, depending on the results of the piano audition) within the freshman year in order to complete the 14-credit piano requirement within four years.

Revised version:

The program leading to the Bachelor of Arts degree with a major in Music contains two tracks: Music/General Studies or Music/Composition. The General Studies track is designed to give the student a general experience in music within a liberal arts degree, and allows students to explore a minor in another area. The Music/Composition track is a specialized program that will prepare the student for graduate studies or a career in music composition. Students wanting to choose the Composition Track must audition to enter the Music Department in any other music degree. Entrance to the Composition Track occurs after completion of Theory I-IV, Theory Skills I-IV, and Composition I, which, for the prospective major, is to be taken concurrently with Theory IV and Theory Skills IV. On completion of these courses with a 3.00 GPA or higher, the Theory Composition Area Coordinator will advise the student into the Bachelor of Arts Music/Composition Track. The prospective major must begin study of piano (either Class Piano or Applied Piano, depending on the results of the piano audition) within the freshman year in order to complete the 14-credit piano requirement within four years.

2. Summary of changes

- 1. The Music/History and Literature Track will be placed in moratorium and deleted.
- 2. In the Music/General Studies Track:
 - o The ENGL 121 Humanities Literature requirement is replaced with an upper-level English literature course from the following: ENGL 210-214, 225-226, or 340-398
 - o APMU (Major), Applied Music requirement, is reduced from 16 to 12 credits; students will take Applied Music levels I through VI instead of I through VIII
 - o MUSC 153 and 154, Class Piano 1 and 2, are added
 - o MUSC 180. Technology for General Musicianship, is added as a controlled elective
 - o MUSC 217 and MUSC 218 are combined as MUSC 217, which is expanded from a total of two credits to three credits. The requirement of courses with MUSC or MUHI prefix for the remaining 0-2 credits is added.
 - o All electives are now free electives and are expanded from 16 credits to 22 credits. Students will be encouraged to consider a minor in another department.
 - PHYS 105 requirement is changed to "recommended" to increase scheduling flexibility

3. In the Music Theory/Composition Track:

- o The name of the track is changed to "Music/Composition."
- o MUSC 180, Technology for General Musicianship, is added
- o MUSC 217 and 218 are combined as MUSC 217, which is expanded from a total of two credits to three credits
- o MUSC 304, Form and Analysis I, is renumbered as MUSC 418 and expanded from two credits to three credits
- o MUSC 306, Counterpoint I, is renumbered as MUSC 415 and expanded from two credits to three credits
- o MUSC 309, Orchestration I, is renumbered as MUSC 417 and expanded from two credits to three credits
- o Controlled electives are expanded from four credits to eight credits
- o MUHI 102, Music and Literature Survey, will fulfill the Humanities Literature liberal students requirement, and ENGL 121 is deleted
- o PHYS 105 requirement is changed to "recommended" to increase scheduling flexibility
- o Free electives are deleted

MUSC 180, Technology for General Musicianship

c. Rationale for Change

The Music History/Literature track is being deleted because of low enrollment, because the degree was essentially impossible to complete in four years, and because the degree did not meet the standards of the National Association of Schools of Music (NASM) for music history degrees. Students could pursue an interest in music history in the revised General Studies Track.

Revisions of the Music/General Studies and Music/Theory and Composition Tracks are necessary for the Department of Music to secure NASM accreditation. NASM distinguishes between liberal arts and professional degrees, and requires that liberal arts degrees have no more than 45% studies in music while professional degrees must have at least 65% of studies in music. The Music/General Studies Track corresponds to the liberal arts model, but had more than 45% in music. The Music/Theory and Composition Track corresponds to the professional model, but had less than 65% studies in music. In addition, the Theory and Composition track did not fulfill NASM's requirements for both Theory and Composition, so we are renaming it the Music/Composition Track. Other changes are intended to clarify, clean up, and/or rationalize aspects of the tracks.

Specific changes in the General Studies Track:

- 1) Replacement of ENGL 121, Humanities Literature, with an upper level English course: Because MUHI 102, Music and Literature Survey, is team-taught by English and Music, and already fulfills the humanities literature requirement for music education majors, we felt that students in the B.A. degree, who must take MUHI 102 and ENGL 121, should be allowed to take an upper-level literature course instead of essentially repeating the content of ENGL 121.
- 2) Change from "requirement" to "recommended" for PHYS 105. Restricting the lab science requirement to this one course can make it difficult for students to schedule it.
- 3) Reduction of APMU from 16 to 10 credits: This is to make room for liberal arts classes.
- 4) Addition of MUSC 153 and 154, Class Piano I and II: Students are required to have piano proficiency, and most were taking these courses anyway, so it made sense to add them to the degree program.
- 5) Addition of MUSC 180, Technology for General Musicianship: NASM requires that all music students have appropriate technology training in the discipline.

6) Increase of free electives from 16 to 22 credits: This increases the proportion of general studies in the track, and makes it possible for students to complete a minor in another department; advising students to consider a minor will help to ensure the liberal arts focus of the track.

Specific changes in the Composition Track:

- Replacement of ENGL 121, Humanities Literature, with MUHI 102, Music and Literature Survey: Because MUHI 102 is team-taught by English and Music, and already fulfills the humanities literature for music education majors, it makes sense to extend this to Composition majors. Also, this helps to increase the proportion of music studies in the track.
- 2) Change from "requirement" to "recommended" for PHYS 105. Restricting the lab science requirement to this one course can make it difficult for students to schedule it.
- 3) Revision of MUSC 217/218, 304, 306, and 309: These revisions add further to the proportion of music studies in the track, and recognize the complexity and importance of these skills. Also, combining the two semesters of Keyboard Harmony into one makes it easier to schedule. Renumbering MUSC 304, 306, and 309 will make it possible to dual-list these courses with graduate courses in theory, which will help the department in scheduling graduate courses.
- 4) Addition of MUSC 180, Technology for General Musicianship: This is to fulfill a NASM requirement for technology competency in professional degrees.

Part III. Implementation

1. How will the proposed revision affect students already in the existing program?

Since there are currently no students enrolled in the History/Literature track, only new students would be affected by its deletion; those students will be advised to consider the General Studies track instead.

The primary effect on students in the General Studies track will be that they will now have room in their studies to explore many more courses outside of music, including a minor in another department. Students currently in the program could easily adapt the majority of their courses to the new requirement, and all of the classes those students are currently counting on will still be taught.

For students in the current Theory/Composition track, some of the classes they are expecting will expand from two to three credits, requiring some extra work. For keyboard majors in the B.A. and B.F.A., keyboard harmony will expand from a total of two credits to three credits, requiring some extra work.

2. Are faculty resources adequate? If you are not requesting or have not been authorized to hire additional faculty, demonstrate how this course will fit into the schedule(s) of current faculty.

Present faculty complement may be adequate, but additional faculty complement may be needed to cover the expanded courses (MUSC 217, Keyboard Harmony; MUSC 418, Form and Analysis I; MUSC 415, Counterpoint I; MUSC 417, Form and Analysis I). However, the total number of credits in expanded courses totals only four credits, and these courses are taught on a two-year rotation, so the impact should be minor. The reduction of APMU (private lessons) in the General Studies Track from 16 to 10 credits may free up some complement.

3. Are other resources adequate? (Space, equipment, supplies, travel funds)

The proposed revisions will not increase demand on classroom space, equipment, supplies, travel funds, etc. All of the physical resources needed for implementation of these program changes already exist within the department.

4. Do you expect and increase or decrease in the number of students as a result of these revisions? If so, how will the department adjust?

It is unlikely that enrollment will significantly change as a result of these revisions, but the expanded flexibility of the B.A. degree could draw in some new students.

Part IV. Periodic Assessment

Departments are responsible for an on-going review of curriculum. Include information about the department's plan for program evaluation:

1. Describe the evaluation plan. Include evaluation criteria. Specify how student input will be incorporated into the evaluation process.

Since these program revisions are driven by requests from our accrediting agency, we intend to look to NASM to provide feedback on our degree program evaluation. Their criteria for evaluations change with every evaluation and every evaluation group. We might look to the number of students completing the degree as a sign of success of a given program, but NASM might not. This is a peer-review process, so often the changes are requested as the result of having a certain group of reviewers involved in the evaluation.

2. Specify the frequency of the evaluations.

NASM evaluations take place every 10 years.

3. Identify the evaluating entity.

The National Association of Schools of Music (NASM) is the largest organization of music departments nation-wide. The process of evaluation involves a team of three evaluators from like-sized music departments from around the country.
