Students majoring in political science have employment opportunities in federal, state, and local governments and with private civic groups, interest groups, and political groups. Students who go on to graduate work find appointments at higher levels and in college teaching. Students graduating in political science, as in any of the social sciences, are in demand by employers in business and industry. Students completing the political science internship program have experienced considerable success in finding employment upon graduation. The political science major is also especially suitable for the pre-law student.

Rationale/Justification. A minor in Homeland Security is appropriate for many majors in the social sciences and natural sciences. The United States Department of Homeland Security aligned twenty-two agencies under a single department with a mission that includes prevention and protection against threats and disasters of all kinds. The Homeland Security minor is designed to assist students in gaining knowledge of the political aspects of this subject area. The minor requires eighteen credits in PLSC courses, with the exception that CRIM 344 can be substituted for PLSC 344. The 100 level courses must be completed prior to taking the remaining four courses.

Minors in Homeland Security (or a close variant) are offered at many colleges and universities, e.g., the University of Maryland (online), SUNY – Canton, and Penn State (online, "World Campus"). Penn State also offers an M.A. and a Certification in the field. California University of Pennsylvania offers a M.S. in Legal Studies: Homeland Security (online, "Global Campus"), and Westmoreland County Community College offers a Certificate.

Part III. Implementation.

- 1. Faculty resources are adequate. The courses required for this minor already are offered in the department, with the exception of PLSC 344 which is in the process of being cross-correlated with the existing course CRIM 344. The Department of Criminology will assist in offering the required course PLSC 344/CRIM 344 Terrorism.
- 2. Space, equipment, and supplies are adequate.
- 3. It is hoped that the addition of this minor will boost enrollments in various PLSC courses, especially the two introductory courses. However, with the addition of the authorized new tenure-track faculty member in Middle East Politics, Fall 2014, the department will be able to accommodate additional students.
- 4. Intended Implementation date: Spring 2014

Part IV. Periodic Assessment.

A thorough assessment of all minors in Political Science is undertaken as part of the Department Five Year Review. More frequent informal assessments will be completed by the Chair and the course instructors. The criteria of assessment will primarily be (1) enrollments in the minor and (2) usefulness of the minor to various majors. The latter will include student input based on emails to declared minors.
