During the fiscal year that ended June 30, 2022, IUP provided support to the Foundation for IUP totaling \$18,087. The foundation provided funding, services, and other support to, or on behalf of, IUP totaling \$9,987,628. Additionally, the foundation made available to the university and university students facilities valued at \$88,603,035, including 2,190 beds for student housing. The reciprocating beneficial activities between IUP and the foundation comply with Board of Governors Policy 1985-04-A.

There is an IUP/Foundation for IUP Memorandum of Understanding in effect, and the foundation has provided IUP with a copy of its FY2021-22 audited financial statements.

CERTIFYING RESOLUTION BOARD OF GOVERNORS POLICY 1985-04-A UNIVERSITY EXTERNAL FINANCIAL SUPPORT FOUNDATION FOR IUP

WHEREAS, Board of Governors Policy 1985-04-A, University External Financial Support, permits Pennsylvania's State System of Higher Education universities to establish relationships with various affiliated organizations, provided that they comply with certain criteria;

WHEREAS, Indiana University of Pennsylvania (IUP) has established such relationships, and a memorandum of understanding exists between IUP and the Foundation for IUP, an affiliated organization;

WHEREAS, a statement for FY2021-22 is provided by IUP's chief financial officer, summarizing the direct university support provided to the Foundation for IUP and the contributions made by the Foundation for IUP to the university;

WHEREAS, the IUP Council of Trustees certifies that, to the best of its knowledge, information, and belief, the Foundation for IUP is in compliance with Board of Governors Policy 1985-04-A, in that it exists solely for the benefit of the university and the expectations of the relationship between the university and the Foundation for IUP are recorded in a memorandum of understanding;

WHEREAS, IUP receives copies of the annual audit reports of the Foundation for IUP;

NOW, THEREFORE, BE IT RESOLVED, that this resolution is approved by action of the IUP Council of Trustees during the quarterly meeting held December 8, 2022, in Indiana, Pennsylvania.
