### Counseling Department Adds Two Full-Time Faculty

Thanks to the advocacy work of Dr. John Butzow, Dean of the College of Education and Educational Technology, the department received 2.5 permanent faculty positions to support the growth of the department, primarily the Monroeville MA program. The department chose to forgo a national search because we were so impressed with the work of Dr. Robin Rishel and Dr. John McCarthy. As a result, we were able to move both of them from their current temporary positions to permanent tenure track positions! We chose to forgo a national search because their strong skills and expertise complements ours, they have already demonstrated their commitment to the department and our off-campus programs; and they are tremendous individuals to work with and have already begun to assimilate into our departmental culture.

Alumni Spotlight: Bob Sukolsky

I am currently a Program Director at Spectrum Family Network. Spectrum Family Network is a non-profit social service agency that provides a broad range of services to children and families across five counties in western Pennsylvania. Our central office is in Allegheny County, with offices Westmoreland, in Washington and Fayette Counties. We also serve a small population in Beaver County. I am responsible for the offices in Westmoreland, Washington and Favette. There are approximately 42 staff serving between 200 and 300 families in these three offices. While these three offices predominantly provide in-home services, we also provide foster care, residential, family based mental health, wrap around and drug and alcohol services. We are preparing to provide MISA services in Washington County.

Our agency philosophy is to keep families intact, but if that is not possible, to provide them with a safe, nurturing environment in which to grow. We believe in partnering with the family and other service providers to engage in a strength-based, respectful therapeutic approach that addresses the needs of both the children and the families. Our approach is contextual and systemic in nature, as we see our families and ourselves as a part of the communities in which we live and work and attempt to connect these families with the community. Because of this belief, we strive to be culturally competent.

I have been employed at Spectrum Family Network (formerly Alternative Program Associates) since I graduated from the Counseling Department at IUP in December of 1991. I was originally hired as an in-home therapist, was promoted to clinical supervisor, then Program Manager and finally Program Director in July of 2001. This job has been frustrating, challenging and rewarding all at once. I still utilize many of the skills developed as a therapist, but in a different context.

In addition to my full-time position, I also maintain a small private practice, which provides individual, family and couples counseling. I have been an adjunct instructor at Duquesne University for the past two years. I taught in the Counselor Education program at Seton Hill College, but quit to obtain more education. I am currently pursuing an Ed.D in the Clinical Supervision and Counselor Education Program at Duquesne University.

#### Alumni Spotlight: Susan Sibert Proud Words of an Alumni

Those of us who work in counseling are used to dealing with difficult situations and problem solving.

We know that anytime the office phone rings, it could bring a new challenge or complaint. Who wouldn't like to receive a call that brings good news and a compliment? Recently, Dr. Claire Dandeneau received such a call from me, a Counselor Education alumni from 1993.

I work as a school administrator in the Purchase Line School District in Indiana County and recently chaired an interview team for an elementary counseling position. A number of the candidates for the position were IUP graduates. I was so impressed with the quality of the applicants that I really wanted to share my observations with Dr. Dandeneau, who was thrilled but not surprised. I found the quality of the IUP applicants to be excellent.

In talking to the candidates during the interview process, I could see the high standards of course work expectations and the depth and breadth of the internship experiences coming through. Our interview team was so impressed, we wanted to share our experience with the department.

The interview team was so pleased, in fact, that they hired IUP graduate Cindy Risinger to fill the position. We are excited to have a superb counselor like Cindy working with our students, faculty and parents.

Since graduating from the program in 1993, I have earned a second master's degree in Educational Leadership as well as elementary and secondary principal certification from St. Francis College in Loretto. I have worked as a teacher, elementary counselor, secondary counselor, and I am now in my fourth year as an elementary principal and district federal program coordinator.

I have also served as a adjunct faculty member in IUP's Counselor Education program and at Mount Aloysius College in Cresson.

The impact of licensure in Pennsylvania on alumni of our program is quite varied. Everyone should be informed that the Governor has extended the grandparenting for licensure to February 19<sup>th</sup> of 2003. The extension will allow for more alumni to apply to be licensed under this section of the law. Many of you have called seeking assistance. I have done my best to help you and tried to respond to your individual needs/cases. I wish there was a one-step easy process that the department could do to facilitate the licensure and grandparenting process for all of you. Since this is new to all of us and we are under a very quick time deadline, I thought that it might be helpful to provide a list of frequently asked questions and answers.

The deadline for grandparenting has been extended, but what does that mean in practical terms? There are several criteria for grandparenting, but the one that is most critical is that you must hold a national counseling credential. This means you must be a Nationally Certified Counselor (NCC). Information about the NCC credential can be found at http://www.nbcc.org. In order to get the NCC, many of you may need: courses to total 48 credits, a multicultural/social foundation course, a career class or an ethics class, and in some cases, a second "field" experience. If you are NOT a NCC and are wanting to apply for licensure under the grandparenting clause, it is **critical** that you understand that there is **ONLY ONE** exam (one of the criteria for NCC) being given between now and the end of the grandparenting time period. The deadline for applications to sit for the October 19<sup>th</sup> exam is July 15<sup>th.</sup> Normally, you would need to have all course work requirements completed by the deadline. However, I have made arrangements with the National Board for Certified Counselors to allow our students to apply with course work in progress over the summer. To do so, there are three stipulations: 1. Your application must be completed and submitted to NBCC by the July 15<sup>th</sup> deadline; 2.) it must be accompanied by a letter from me verifying that you are enrolled in the coursework; and 3.) you submit an official

transcript **as soon as** you complete the coursework. Please remember that you still MUST meet all the general requirements, not just the coursework, to be eligible to sit for the exam and receive your NCC.

Can the department audit my transcripts and tell me what courses I need to sit for the NCE

**exam?** The National Board for Certified Counselors (NBCC) officially conducts the audit process that makes one eligible to sit for the exam. The department is not in a position to make any decisions with respect to your eligibility for the exam. Our best advice: Call NBCC for an application or print out the application that is available on-line (you must have Adobe). In that application, there is a course checklist called the Verification of Coursework. All you need to do to conduct a self-audit is to place the courses that appear on your transcripts in the appropriate places on the checklist and you will know exactly what type of courses you will need to sit for the exam.

Are there any grandparenting provisions for alumni who graduated with less than a 36 credit hour degree? I have talked with the State Board of Social Workers, Marriage and Family Therapists and Professional Counselors and there is absolutely no way to get licensed under the grandparenting section of the law.

I have done my own course audit and know that I need additional classes, what should I do to be able to take classes this summer? You need to apply to the graduate school either for a one course only or if you need more than one course, for the licensure only admission status. You can get an application by calling 724-357-2222. All registration for courses and the actual course schedules are on-line. There is no longer telephone registration or paper schedule booklets. You will receive information on how to register from the Graduate School and course offerings can be found at http://www.iup.edu/ursa.

### **Special Summer Course Offerings**

The Counseling Department will be offering two Special Topic courses this summer. These courses are available for Act 48 credits.

### "Caring Children Build Caring Communities: Classroom Strategies for Learning and Caring" COUN 681 001

*Caring Children* is a dynamic, interdisciplinary, and experientially based workshop for educators who wish to help children care more deeply,

manage risk more responsibly, and experience life more fully. Props, magic, humor, storytelling, and other techniques will be used to teach: Life has Value, Seven Themes of Caring, Good Habits – Bad Habits, Hazards and Dangers, Learning to be Careful, and Adventures in Community Building in the Classroom. Schools become caring and safe places when all the people in them become generous care givers and appreciative receivers of care.

This class will be offered June 24-28, 2002 from 8:30 am – 4:30 pm and is appropriate for elementary school teachers, administrators, and graduate students.

### Special Topics: "Diagnostic and Treatment Issues for Counselors" COUN 681 002

This course provides an introduction for counseling students on the various mental disorders with a focus on the history of the major classification system, definitions of various disorders, and the corresponding diagnostic criteria. Current research on treatment approaches for counseling professionals will be examined. Finally, this course is designed to help students' view the mental health needs and challenges of clients from a lifespan and multicultural perspective.

These classes will be meeting May  $18^{th}$ , June  $1^{st}$ ,  $8^{th}$ ,  $15^{th}$ , and  $22^{nd}$  from 8 am –12 pm and 1pm – 4 pm with a 1 hour lunch break from 12 - 1 pm.

### Wellness Course Offered for First Time

Dr. Robin Rishel is excited to be teaching a newly offered elective, COUN 681: Wellness-based Counseling, being offered at the Monroeville campus this spring. This course was selected by the first Monroeville cohort as an elective. With the collaboration of Dr. Jane Myers from the University of North Carolina, Dr. Rishel developed this course and reports that it has been an exciting and rewarding challenge.

In the course, students are learning about theories surrounding personal change as well as assessing their personal levels of wellness and past change attempts. Assignments include taking a

wellness assessment, scoring the instrument and designing a personal wellness profile and plan using a wellness workbook. Students are also to administer and evaluate one other volunteer client. Students are working in groups under the headings designated by the Wheel of Wellness, critiquing research articles and presenting group projects on each of the following topics: Spirituality, Work and Leisure, Self-Direction, Friendship and Love. There are also a number of guest speakers that have been invited to share their expertise on such areas as Spirituality and Worksite Wellness programs.

The students seem enthusiastic about the course and Dr. Rishel hopes to teach this class again in the future.

The Counseling Department just recently completed a 5-year review and self-study. Within this study, it was found that the faculty does much more than teach a few classes. According to this 5-year study written by Dr. Nadene L'Amoreaux, the Counseling Department faculty does plenty in their "free time."

"In addition to making progress toward college and department goals, Counseling Department faculty are also actively involved with departmental, college and university committees as well as university governance. In addition, the faculty members are actively involved in various scholarly activities and service activities. During this review period, they have collectively held memberships in 32 professional organizations, including ACA and APA and their respective branches, divisions, or affiliations; they have conducted approximately 65

presentations at the local, state, regional, and national levels; and they have approximately 36 publications ranging from book reviews to peer reviewed articles in premier counseling journals."

### Impact Therapy Workshop with Dr. Ed Jacobs



On February 1st, the department sponsored a workshop with Dr. Ed. Jacobs, entitled "Impact Therapy: A Creative Approach to Brief Therapy" at the CCAC, Boyce Campus in Monroeville. School counselors, com-

munity and mental health counselors, graduate students, and other professionals were in attendance to gain more knowledge about Dr. Jacob's multi-sensory approach to counseling.

Video segments and role-play scenarios were used to demonstrate various techniques and creative props that could be implemented into the counseling process. Dr. Jacobs commented, "It's a wonderful profession – if you have the skills." Throughout the workshop he emphasized the importance of counselors adding to their 'toolbox' and acquiring new effective skills that could be beneficial for clients.

### Counseling Department Student Awarded Scholarship

### What is it like to be in a Cohort?
