Welcome to this edition of the Department of Counselina Newsletter. 1999 has brought important advancements within the Department and for Professional Counseling in PA. The University Senate approved all department curriculum revision proposals on May 4th. The 1998 December Newsletter outlined proposed changes to the M.Ed. & M.A. programs.

Both of the programs will increase to 48 credits, allowing students to meet the minimum credits required by PA licensing and national certification standards.

The Community Counseling program was approved for the Pittsburgh/Monroeville Center beginning January 2000 (see article on page 3). In addition, a "License Only" Admission option was approved. This is designed for master's level counselors needing additional credits to meet PA licensing standards (see article on page 3).

On December 21, 1998, Governor Ridge signed Senate Bill 619 into law, resulting in Act 136 of 1998. This act provides for licensing of professional counselors. While it may be some time before specific regulations are developed, licensing for counselors is finally a reality in PA. See article on page 2 for more on counselor licensing. We completed a nationwide search for a 6th faculty member. Nadene L'Amoreaux, completing her doctorate at Kent State University, will be joining our faculty this fall (see article in opposite column).

The 2nd Spinelli Scholarship was awarded to Nancy Chelgrin and the 1999 Outstanding Student award was received by Mindy Heher (see pg. 5 for further details). Twelve students were initiated into lota Upsilon Pi, IUP's chapter of Chi Sigma lota National Honor Society (see page 5). We hope you find this Newsletter issue informative and look forward to your reactions!

Nadene A. L'Amoreaux is joining our faculty in the Fall '99 semester. She was identified as a result of a nation-wide search, which involved 60 applicants. She is completing her doctoral dissertation at Kent State University from

the Counseling & Human Development program.

Nadene's dissertation focuses on perceptions that preadolescents and adolescents, diagnosed with ADHD, have about interventions used by their parents. She was highlighted in the December 1998 Newsletter as she taught in our Department as an adjunct faculty member during the past year. Nadene has been a teaching fellow at Kent State, teaching and co-teaching practicum, introduction to community counseling, small group processes, introduction to counseling procedures, and couples theory and technique.

Nadene completed her BA from Hiram College, received her MA degree from Edinboro University of Pennsylvania, and she is a certified rehabilitation counselor. She has experience working with children in a partial hospitalization program, and counseling adolescents, couples, and families.

We welcome Nadene L'Amoreaux to the Department, and hope alumni get the opportunity to meet and interact with her.

Career Works



Dr. Karen Rivosecchi and students enrolled in a career development class designed and implemented a "Career Works" workshop for the ARIN IU Pregnant & Parenting Teens Program. Fortytwo teens from Indiana & Armstrong counties participated in the four-

hour workshop held at the Rustic Lodge located in Indiana.

The counseling students constructed a rating scale to determine what career-related topics were of interest to the teens. The list generated three areas: Life Skills, Job Readiness, and Positive Parenting.

Participants attended workshop sessions on two of the above topics and a panel discussion comprised of representatives from local schools. Representatives from IUP, Triangle Tech, and other post-secondary programs were available to provide information and respond to participants' needs.

Manda Fisher and Joy Sottile (Community Counseling students) shared their experience of working on the project. Manda said that "working on this project provided an opportunity to work with the different systems, such as the school, community, and counseling professionals. It was nice to have a class where we could apply what we were learning and see the results." Joy said "It was a good opportunity to help kids, if we made an impact or left an impression in a few of their minds, then the time and effort that we put into this project was well worth it."

Counselor Licensing

On December 21, 1998, Governor Tom Ridge signed Senate Bill 619 into law: Act 136 of 1998. This act provides for licensing of professional counselors, marriage and family therapists, social workers, and clinical social workers. In the December 1998 Newsletter we included major sections of the law related to qualifications for licensure and requirements for grandparenting. We have been receiving many inquiries from alumni and others about counselor licensure. All the information available is included on the Legisla-

Following are excerpts from this PCA website:

On May 11th the Governor announced his appointments for five of the six new members of the Board of Social Workers, Marriage and Family Therapists, and Professional Counselors. The following individuals have been referred to the PA Senate for confirmation: Raymond Hoover of Camp Hill and J. Michael Wilkins of New Castle were nominated to fill two of the Professional Counseling positions.

Once the new board members are confirmed they are required to meet within 30 days to set up operating procedures and develop licensing application forms. They are then required to adopt rules and regulations necessary to carry the Act into effect. There is no statutory deadline for the board to develop rules and regulations, and it is difficult to predict how long it will take.

The process of implementing the Act could take 18 months to two years, but it is difficult to predict. The Board will be deciding a variety of issues that will be very important to potential licensees, graduate programs, and agencies, which hire counselors. Issues relating to what degrees and training are considered appropriate; what national credentials (which require a masters degree or above and a test) may excuse someone from having to take another test; and, what test will potential licensees have to take, are among the decisions the Board will make.

Based on the information stated in the Act, the recent revisions made to IUP counseling programs would meet the 48-credit degree program requirement. As new information becomes available we will include it in the Newsletter and on our dept. web page: http://www.iup.edu/ce

We will do our best to advise individuals on how to proceed with licensure issues, but the Licensing Board will have the final authority on all licensing decisions. So, though we will be happy to help, the faculty cannot be held accountable for the subsequent decisions of the Board, especially as many procedures are still to be decided by the Board.

Monroeville Program

The Community Counseling Program (MA) has been approved by the University Senate and administration to be offered at the IUP Monroeville Graduate and Professional Center located at 470 Mall Circle Drive, Monroeville. Bob Witchel will be coordinating the program, which plans to admit about 25 students into the first cohort to begin classes in January 2000. A second cohort is planned to be recruited for September 2000. If successful, we anticipate admitting a new cohort each September. Students will enroll in 2 courses each semester (including summers) allowing the program to be completed in two and a half years.

We have been exploring offering a counseling program in the Greater Pittsburgh area for more than ten years. A review of counseling, mental health, and human services agencies in the Pittsburgh Metropolitan area indicates a substantial number of Bachelor's level professionals providing counseling-related services. The recent Counselor License creates an incentive for Bachelor's level counseling professionals to pursue a graduate counseling degree. In order to qualify for a license they will need to obtain a 48-credit master's degree in counseling.

As alumni often recruit and refer prospective students, we encourage you to share this new program location with persons in the Greater Pittsburgh area interested in exploring a master's degree in community counseling.

Licensure-Only Admission Option

The University Senate approved our proposal to develop a "License Only" option for admission. This admission option is designed to help a counselor licensure applicant meet graduate credit requirements. A license applicant has to success-fully complete a graduate program of sixty semester hours in counseling, including a 48-semester hour master's degree in counseling, from an accredited educational institution.

This License Only option is designed for individuals who already have a minimum of a 36-credit hour Master's Degree and need additional credits to meet licensure standards. Alumni, who need additional credits (beyond 36) to meet the licensing requirements, should contact the department to have their transcript(s) evaluated to determine which courses they could enroll in for credit beyond their master's degree.

The final determination of courses acceptable for licensure would made by the state licensing board. If a student had a question about a course being accepted for licensure, they should contact the Licensing Board. Applicants for the "License Only" status must meet similar admission requirements as degree-seeking applicants, which include a minimum 3.5 graduate grade point average.

Alumni interested in applying for the license only option, in order to obtain additional graduate credit to meet licensing requirements, may want to consider enrolling in courses, such as:

*Important information from ACA

The 100,000 New Counselor plan is a reality in the U.S. Senate. The American Counseling Association's effort to educate members of Congress on the need for more counselors has paid off. This week Senator Paul Wellstone (D-MN), plans to offer an amendment to the Juvenile Justice bill, S. 254, that would provide matching grants to fund the "100,000 NEW COUNSELORS ACT".

The Act would provide \$3.7 billion for schools to hire 100,000 new counselors. The Act also provides funds to hire psychologists and social workers. The U.S Conference of Mayors has endorsed the "100,000 New Counselor Act".

America's schools have a serious shortage of school counselors. The U.S. average student-to-counselor ratio is 513:1 --- 250:1 is the maximum recommended ratio. If we are to bring down the student-to-counselor ratio we need to hire 100,000+ new counselors.

Fund Elementary & Secondary School Counseling

Another amendment on the Juvenile Justice bill, S. 254, is the being offered by Senators Harkin (Dlowa), Blanche Lincoln (D-AR), and Paul Wellstone (D-MN) that would authorize the Elementary School Counseling Demonstration Act for \$100 Million and extend the Act to provide services in secondary schools.

The Elementary School Counseling Demonstration Act will provide funding to schools so they may hire counselors, and expand counseling and pay for direct counseling services in the schools. The amendment targets \$60 million for elementary schools.
