# IUP COUNCIL OF TRUSTEES' EXECUTIVE SESSION

The IUP Council of Trustees met in executive sessions today to discuss personnel issues, collective bargaining/labor relations matters, acquisition of real estate, litigation, and other privileged and confidential matters.

# **READING AND CONSIDERATION OF THE MINUTES**

The following motion was approved:

# **REPORT OF THE PRESIDENT**

Dr. Driscoll welcomed everyone and said that he is pleased to have this meeting at the Punxsutawney campus and that sometimes a change of venue is needed as a reminder that IUP is a multifaceted university.

The students at the Punxsutawney campus have formed their own special community—a mix of traditional-age students who are receiving a great start through a special, intimate educational experience, paired with the culinary students, who embark on a very focused and demanding curriculum. The hospitality the students and staff have shown is greatly appreciated, and special appreciation goes to Dean Terry Appolonia, Chef Albert Wutsch, and their staffs.

Despite the decline in demographics, IUP is on track to meet next year's enrollment goal—a total of 14,368 students—based on the number of applications and deposits. In 2012, the Council of Trustees approved a grant that provided the Admissions office with scholarship funding for qualified students. That action has greatly assisted with this success, as have stepped-up marketing efforts. Based on the most likely scenario for the next fiscal year budget, IUP will face a modest shortfall. To maintain a balanced budget and adequate reserves, the university will need to identify additional revenue, including the fee increase being considered by the trustees today, and make permanent budget reductions.

After significant consultation with the University Budget Advisory Committee and the President's Cabinet, Dr. Driscoll instructed the vice presidents to work with their divisions over the next 60 days to identify their share of the reductions. He said he will have additional information to report at the May Council of Trustees meeting.

The president noted that copies of *Points of Pride*, a comprehensive list of accomplishments, were available in the back of the room. While impressive, the list does not reflect the pace of the work across the university, nor some of the large, positive strides being made.

IUP was very fortunate to receive from alumni Tim and Debra Cejka a \$1.25-million gift in support of the new science building, currently in the planning stages. Tim Cejka serves on the Natural Sciences and Mathematics Advisory Board, which is helping to create a plan that considers the best educational options for future scientists and mathematicians—preparing them for today, as well as for situations they may encounter in the future. The Cejkas provided this gift as a spark, and they hope their investment will inspire others to invest in IUP.

Dr. Driscoll noted that acquisitions were not confined to the financial. In May, the Music Department will acquire the Pogorzelski-Yankee Memorial Organ, valued at \$400,000. This pipe organ comes to IUP through a renewable lease from the American Guild of Organists, which received it through a bequest. The Music Department earned the privilege to house the organ through a competitive process. Organ professor Christine Clewell wrote the proposal. For years, the department has diligently promoted the Carol Teti Memorial Organ Scholarship to combat the shortage of organists in rural areas throughout the United States. Having a magnificent instrument like this on campus makes organ studies more appealing to future professional musicians.

The president reported that the IUP Research Institute, in partnership with the Pennsylvania Game Commission, received from members of Congress the State Wildlife Action Plan Partnership Award for outstanding achievement in implementing the state's wildlife plan. An IUP contingent accepted the award in Washington, DC. The president quoted the press release distributed by the Association of Fish and Wildlife Agencies, which said, "IUP researchers are among the commission's most valuable partners as a result of the [IUP Research] Institute's understanding of the Pennsylvania Wildlife Action Plan, coupled with experience of finding and implementing solutions to the state's conservation needs."

In January, Caleb Finegan agreed to become the director of the Cook Honors College. He succeeds Janet Goebel, the founding director. Dr. Finegan is a member of the History Department faculty, and he has a longstanding commitment to student engagement at IUP. He founded IUP's Alternative Spring Break program, which arranges for students to forgo the usual spring break beach ritual in favor of conducting community service projects in locations across the country. Dr. Finegan personally led a special study abroad experience—a 500-mile pilgrimage along El Camino de Santiago in Spain. Early in his career, he received a Fulbright Scholarship, which funded research in Bolivia.

The university's Middle States Self-Study is progressing. In February, Debra Klinman, from the Middle States Commission, met with various groups on campus to provide insight into the process. Leaders of the self-study, Hilliary Creely and Laura DelBrugge, submitted before Dr. Klinman's arrival the design plan for the next two years. Dr. Driscoll was pleased that more than 300 faculty and staff members, students, and others volunteered to participate in the self-study. This is yet another indication that everyone on campus is pulling together to help IUP realize its full potential and that the university has a productive work environment.

A second Community University Forum was held recently, and student leaders were on the panel with members of Indiana Borough Council. The intent was to foster discussion between IUP students and the town's residents, creating a better relationship among them. Those students who participated on the panel gained invaluable experience by working with members of the town council. The president hoped that, in the future, a similar forum would be held in Punxsutawney.

The Center for Family Business honored the Reschini Group of Indiana with the annual Family Business Award. Students in the Eberly College of Business and Information Technology benefited from a presentation made by Reschini's top management.

Dr. Driscoll reported that on March 31, IUP would host a high-profile speaker of interest. Probably best known for her battle of the sexes tennis duel with Bobby Riggs, Billie Jean King is also a Presidential Medal of Freedom award winner and was named by *Life* magazine as one of the most important Americans of the 20th century. Ms. King's visit was to be funded by the Ideas and Issues series.

The president stated that IUP has awarded the President's Medal of Distinction for more than 25 years. In that time, the award has been presented to luminaries and dignitaries who have served the university community honorably. Several current members of the Council of Trustees have received it, such as Susan Delaney, Gealy Wallwork, and James Miller. This year, the award was to be presented to someone whose perspective is one of influence and whose service to the university has been honorable as well as crucial. It was the president's wish that the trustees would join him at Indiana's annual Leader's Circle event on April 10, when he was to have the privilege to honor and thank their colleague on the Council of Trustees, the Honorable Sam Smith.

Bill Speidel, vice president for University Advancement, reported on the alumni receptions since January, which included Florida, Texas, and Charlotte, North Carolina.

He reported on the upcoming Distinguished Alumni Gala, to be held April 12, in which 10 alumni will be honored for success in their professions and service to IUP.

Mr. Speidel highlighted the fund-raising report. Gifts received have surpassed \$4 million, a 68 percent increase over last year at this time. Annual Giving is showing significant progress, recently passing the \$1-million mark. Mr. Speidel announced, as President Driscoll mentioned in his report, that Tim and Deb Cejka have lent their support in the form of \$1.25 million for IUP's new science building.

The feasibility study for IUP's comprehensive campaign will begin in April, with results expected in mid-June. This study will be a critical document as plans are finalized for the campaign.

Mr. Speidel cited the advancement work in Punxsutawney. These accomplishments include recognizing alumni at the 50th anniversary celebration, assisting with special events, and raising funds for the Fairman Centre.

# REPORT OF THE ENROLLMENT MANAGEMENT AND COMMUNICATIONS COMMITTEE

David Osikowicz presented the following report in the absence of Mary Esther Van Shura, chair of the Enrollment Management and Communications Committee:

James Begany, vice president for Enrollment Management and Communications, shared highlights summarizing the division's activities, programs, and accomplishments. He shared an update on the fall 2013 IUP Grant program, as well as a new proposal for the 2014-15 academic year. Included in his presentation was a summary of initiatives for spring 2014 in an effort to increase enrollment. In addition, he shared an update on the success of the Sutton Scholars program, including yield to registration and retention data for IUP's Sutton Scholars.

The committee reviewed the IUP Grant proposal for the 2014-15 academic and fiscal year.
