# MINUTES OF THE IUP UNIVERSITY SENATE

#### **NOVEMBER 5, 2024**

Chairperson Seal called the November 5, 2024 meeting of the University Senate to order at 3:45 PM, in Eberly Auditorium.

#### REPORTS AND ANNOUNCEMENTS

#### **President's Report**

Next Wednesday, November 13, 11:20-12:15, in the Blue Room is our next conversation in the series. I'll be giving a brief update on our progress with the College of Medicine and will provide a glimpse of IUP's future for our ongoing discussion. There will be time for questions and comments.

At the October Board of Governors meeting, we bid farewell to Chancellor Greenstein and welcomed interim Chancellor Chris Fiorentino, recently retired president of West Chester. Chris has already hit the ground running, engaging with key legislators and assessing the work of the Office of the Chancellor. The search for the next chancellor is moving ahead with stakeholder surveys and meetings. The hope is that the next chancellor will be in place next July.

The Board also reappointed IUP student Abby Hancox as a student member of the board and approved a \$2 million capital allocation for design of the renovations needed to house the forthcoming College of Osteopathic Medicine.

The new State Board of Higher Education has met twice, primarily on organizational matters. The board is meant to coordinate all sectors of higher education in Pennsylvania, set strategy and perhaps policy. The board is chaired by State System Board of Governors Chair, Cindy Shapira. Also on the board are ESU president Ken Long and IUP's Bobbie Zapor.

Thanks for all you are doing for our students and to further IUP's mission. Happy Thanksgiving.

#### **Provost's Report**

First, I want to thank folks for all their hard work. These past few weeks, in particular, have been dense with curricular work, and supporting our students in the advising and registration

process. So far, it appears that the registration process is going smoothly. If you are aware of challenges for our faculty, staff, or students, please let me know.

I do want to give you a heads up on some events coming up. On November 21 from 8:00 to 5:00, the Pennsylvania Mountains Rural Health Conference will be held at the KCAC. This is a collaboration between IUP and IRMC. Your affiliation with IUP gains you access to a day full of great opportunities to interact with our colleagues at IRMC. This year's focus is on rural mental health. I encourage you to look at the agenda and stop in for as much of it as you can.

I also have some updates and reminders about Crimson Core. Our team has put together some opportunities for you to get support as we work through the curriculum. There are consultation hours via zoom scheduled every Monday from 11:15 to noon and every Thursday from 2:30 to 3:15, with the exception of Thanksgiving Day. Please feel free to drop in as you are thinking through courses that you would like to propose, or if you have questions about the competencies, guardrails, or expectations for the courses.

I also want to share that Luke Faust sent an email to faculty about an opportunity to explore FLY (First Learning Year) courses. This session will be held on November 22 from 11:10 to 12:20 in B34 Stabley. A zoom link was provided in the email. Again, this is a nice opportunity to explore the exciting courses that we're bringing forward for our students.

In addition, I want to remind you that courses that are to be offered in Fall of 2025 must be submitted through Curriculog by December 13.

Lastly, I'm pleased to share that Cabinet has approved some tenure track faculty searches and some opportunities for exploring some new ways to think about how we meet our curricular needs. Faculty searches have been approved in Safety Sciences and Environmental Engineering, Finance, and Psychology. We are also going to look at some new ways of thinking about a faculty position. We are looking at regular part-time positions and trying to issue earlier contracts for full-year temporary positions in areas we know that we're hiring. We are also looking at internal transfers as a way to meet some of our needs. This is a clear demonstration that we are meeting our sustainability goals and starting to rebuild in a good direction.

#### FRESHMAN APPLICATIONS

SAT or ACT scores are not required for admission. New students can be admitted without SAT or ACT scores to select majors if high school cumulative GPA requirements are met. For those students who choose to take the SAT or ACT, it's recommended to test during the junior and/or early part of the senior year. If a student tests more than once, the committee considers the highest scores from all tests taken.

In order for the test scores to be received by IUP, the applicant should designate IUP on the test registration form (SAT code 2652, ACT code 3704) as one of the universities to receive the scores, or the applicant can request that his or her school counselor forward test scores to the Admissions office.

#### UNDERGRADUATE ADMISSIONS POLICY

Graduates of an accredited four-year high school or holders of a GED equivalency diploma are qualified to apply for admission to IUP. Students who have completed the junior year of high school may file an application any time after July first. Requests for applications should be addressed to

The Admissions Committee, giving equal opportunity to all students, will take the following criteria into consideration when reviewing each application: grades and courses taken, SAT or ACT scores, if available, high school counselor recommendations, and other pertinent information that would be helpful to the Admissions Committee in making decisions. New students can be admitted without SAT or ACT scores to select majors if high school cumulative GPA requirements are met. SAT or ACT scores, are not required for transfer applicants, veterans, or applicants who have graduated from high school more than one year before applying. However, transcripts from high school and all colleges previously attended are required of all applicants.

Applicants are strongly urged to take the usual college preparatory program in high school. Applicants should also take any available high school courses in the field of their intended major. Certain majors at IUP require completion of a foreign language at the intermediate level to earn a bachelor's degree. The Admissions Committee does not require an applicant to take a foreign language in high school for admission to these majors; however, it is in the student's best interest to do so.

SAT/ACT scores are not required for merit scholarship consideration at IUP, but if submitted, could potentially impact the amount of scholarship dollars offered. If you are applying for scholarships external to IUP, test scores may be required for consideration

Applications are considered by the Admissions Committee on a rolling basis. Under a rolling admissions policy, applications are reviewed as they become complete. Decisions can range from automatic acceptance, to requests for additional information, to other alternatives, with a May 1 deadline for nonrefundable tuition deposits.

Academically qualified applicants to the departments of Art, Music, and Theatre and Dance will be admitted to the university by the Admissions Committee. However, admission to the requested major will be subject to the acceptance by the Department of Art after a portfolio review and by the departments of Music (all majors), and Theatre, Dance and Performance departments after an audition. Students will receive information from the Art, Music, and Theater and Dance departments concerning auditions and portfolio reviews once they have been accepted to IUP.

Academically qualified applicants to the majors of Music, Musical Theatre, and Graphic Design will be admitted to the university by the Admissions Committee. However, admission to the requested major will be subject to the acceptance of the academic department where the major resides after a portfolio review (Graphic Design) or an audition (all Music majors and Musical Theatre) by these departments. Students will receive information from these departments concerning auditions and portfolio reviews once they have been accepted to IUP.

**Rationale:** The Academic Committee worked with Admissions to ensure that this policy was reflective of current requirements and references.
