4. An exact statement of what is to be deleted

The course GRMN 102 German II (3 cr) is to be deleted.

5. Justification/Rationale

There are two reasons for the deletion of GRMN 102:

- c) GRMN 102 is an inactive course that has not been taught since at least 1990. There is no student demand for it. (It does not appear in the 2010-11 Undergraduate Catalog.)
- d) The German section of the Department of Foreign Languages is redesigning the Elementary and Intermediate language sequence to follow the model of the Spanish section. Three 4-credit courses will replace the current four 3-credit courses. French and Chinese are also going to this model. To align the format across languages, the 102 course number is needed to designate the second course of the new sequence.
